**6) Progress Reports**

**The Developer shall contact or meet with the Client on a mutually acceptable schedule to report all tasks completed, problems encountered, and recommended changes relating to the development of the site. The Developer shall inform**





the Client promptly by telephone or email upon discovery of any event or problem that may significantly delay the development of the work.

**7) Changes**

The Client shall be responsible for making additional payments for changes requested that are outside the scope of the original approved quote.

**8) Testing and Acceptance**

The Developer will make every good-faith effort to thoroughly test all deliverables and make all necessary corrections as a result of such testing prior to handing over the deliverables to the Client. Upon receipt of deliverables, the Client shall both accept the deliverable and make the final payment set forth or provide the Developer with written notice of any corrections to be made and a suggested date for completion, which should be mutually acceptable to both the Developer and the Client.

**9) Confidential Information**

Developer guarantees and warrants all work performed, without expiration, under the terms of this agreement 100%. Upon delivery of final work, warranty requests are not billed to the customer and are valid only when Developer corrects items to conform to the original quote or requested work. Any changes made to the original and final delivered work that are NOT made by Developer are NOT guaranteed and requests for changes will be made at the current hourly rate. Any changes or any type of corrections NOT made by the Developer voids the guaranteed work warranty.
